WHAT DOES THE NIOSH AFF DO FOR IOWANS?

We **develop COVID-19 materials** to help protect farmworkers:

- Contributed content to the national CDC COVID-19 guidance document for Agricultural Workers and Employers
- Translated guidance into relevant tips for Midwest farming operations
- Made videos to explain effective COVID protective strategies on the farm

We **partner with Iowa organizations** to protect farmers:

- Partnered with organizations to reach farmers to improve farmer mental health
- Partnered with farmers and community leaders to examine and improve behavior of drivers around farm equipment on roadways
- Published monthly "Safety Watch" articles for Lee Agrimedia Publications to encourage best practices to protect against seasonal on-farm hazards

We **provide training and services** on safety and health topics:

- Developed and delivered innovative online curriculum for farmers and their advocates
- Hosted regional agricultural health and safety conference to share best practices with farmer advocates
- Developed road safety and manure gas hazard tool kits for extension and other advocates to use as outreach
- Developed and deployed a farm hazard assessment tool to help farmers identify safety improvements on the farm
